**Approval of Minutes** - *Motion by Swenson second by Mulcahy to approve the minutes of the March 1, 2023 meeting. All aye, motion carried.*

**Police Chief Report:** Chief Jerry reported the Police Report was emailed prior to the meeting. **Approve Bills-** *Motion by Charles second by Mulcahy to approve the bills for the general, water, sewer, electric, pool, museum, library and TIF funds as presented. All aye, motion carried.* 

**Public Comment**- Duane Weidge would like to see the "Public Comment" item on the agenda moved further down on the agenda.

**N. Iowa Street Reconstruction-** Mark Doyle, Delta 3 Engineering, presented the council with a copy of the bid sheet. The following bids were received: 1. R & T Voegeli Excavating, LLC-\$74,906.25. 2. Owen's Excavating and Trenching Inc.- \$76,550.95. 3. G-Pro Excavating, LLC- \$83,629.20. 4. Temperley Excavating, Inc- \$85,531.45. 5. Rule Construction, Ltd- \$108,616.45. *Motion by Charles second by Swenson to award the bid to R & T Voegeli Excavating LLC in the amount of \$74,906.25. All aye, motion carried.* 

**Tax Incremental District #6-** Misty Molzof and Cory Rittebusch, Southwest Regional Planning Commission discussed with the council options for TID #6. One option was to make TID #6 a donor TID to TID #7. Another option was to use the funds to invest in another project in TID #6, such as purchase of property. Tom Lethlean feels the funds should be used to purchase land. Dan Morrissey feels the city should do a resolution to purchase the land back from the Lac Du Flambeau Tribe. *Motion by Charles second by Swenson to use the surplus funds in TID #6 for improvements or acquisition of land for the City of Shullsburg within the boundaries of TID #6 as required by law. **Ordinance Prohibiting the Use of Tobacco Products**- The ordinance will be reviewed by the Police Committee before the council takes any action.

**TSR Coating**- After a brief discussion, a motion was made by Charles second by Mulcahy to accept the quote from TSR Coating for the coating of the floors at the bathhouse in the amount of \$15,133.88. All aye, motion carried.

**Lawn Mower/Lawn Tractor-** Motion by Charles second by Swenson to accept the quote from Blackbourns for the purchase of a Yanmar Tractor, with a bucket and mower, in the amount of \$20,000. All aye, motion carried.

**Replacement of Clarifier Gear Reducer**- No action was taken as clarification of the quotes is needed.
