City of Shullsburg Badger Pool Employee Policies

The following pool policies have been adopted by the Common Council of the City of Shullsburg

- 1. No Lifeguards will be allowed to swim after hours.
- 2. Lifeguards must wear appropriate attire at all times when on duty and some piece of attire must identify the Employee as a lifeguard. No two piece suits will be allowed.
- 3. The pool temperature is a vital part of the pool operations. The desired water temperature should remain between 80° and 83° throughout the season. At the beginning of the season the pool covers must be used to get the water temperature up to the desired temperature. Once the water temperature is at the desired level, the pool covers must be used to maintain the desired temperature. The pool manager and assistant manager are responsible for making sure that the pool covers are used at the appropriate times to maintain the desired water temperature. The pool manager/assistant manager should consider the nighttime drop in temperature when considering whether or not the pool covers should be used.
- 4. Lifeguard training costs will be paid in full by the Employee. Employee will be reimbursed half the cost by the City on the Employee's first paycheck after a paid receipt has been submitted to the City Clerk. The second half will be reimbursed on the Employee's last paycheck of the season and is reimbursable only after the Employee has completed the season satisfactorily as determined by the Pool Manager.
- 5. Water Safety Instructor Training will be paid in full by the Employee. Employee must have prior approval by the City before taking the WSI training class. Employee will be reimbursed half the cost by the City on the Employee's first paycheck after a paid receipt has been submitted to the City Clerk. The second half will be reimbursed on the employee's last paycheck of the season and is reimbursable only after the employee has completed the season satisfactorily as determined by the Pool Manager and Park Committee Chairperson.

City of Shullsburg Badger Pool Rules

The following pool rules have been adopted by the Common Council of the City of Shullsburg

- 1. Do not enter the pool if you have a communicable disease or an open cut.
- 2. Do not bring food, drink, gum, or tobacco into the pool area.
- 3. Shower before entering the pool and after use of the toilet facilities.
- 4. Do not run or engage in rough play in the pool area.
- 5. Do not bring animals into the pool area.
- 6. Diaper changing on the pool deck is prohibited.
- 7. Patrons who are not toilet trained are required to wear swim diapers.
- 8. Glass and shatterable items are prohibited in the pool area.
- 9. No street clothes or shoes allowed in the pool area.
- 10. No floating devices allowed.
- 11. Conduct that endangers the safety of others is prohibited.
- 12. Patrons under the influence of alcohol or other drugs will not be allowed in the pool or on the grounds.
- 13. Children must be at least six (6) years of age to enter the pool area unsupervised.
- 14. Children must have supervision when in the baby pool area.
- 15. Individuals must pass a swim test before entering the 10 feet area.
- 16. Must pass the swim test to go into the six foot or beyond or to go off of the diving board.
- 17. No parent is allowed to take his or her child off the diving boards, unless the child has passed the swim test.
- 18. Children who are unable to touch the bottom near the first rope (3 feet) are not allowed to go beyond that rope without an adult.
- 19. Individuals must be at least 3 feet tall and at least 4 years of age to begin level one swimming lessons.
- 20. The pool will remain open, WEATHER PERMITTING, it's listed hours. (This means if it is raining heavy, thundering, lightning or too cold, the pool will close.)
- 21. Family Pass- "Family" is defined as any individual living in a household under one roof. One babysitter would be allowed on the family pass. The name of the babysitter must be listed on the family pass. The babysitter must accompany the children at the pool at all times. The babysitter will not be allowed to use the family pass when he/she is not babysitting.
- 22. The water temperature must be at least 70 degrees and the air temperature must be at least 68 degrees for the pool to open.
- 23. The pool will remain open at the discretion of the pool manager or assistant manager.
- 24. Private Pool Parties- The pool may be rented for private parties. Private parties will not be allowed during the dates and times of swimming lessons. Fees for private pool parties are established by the Common Council per resolution.
- 25. Maximum number of patrons -363.
- 26. Diving only in marked areas.

- 27. One person on the diving board at a time.
- 28. One person on the ladder at a time.
- 29. May not spring more than once on the board.
- 30. Exit to the nearest ladder.
- 31. No lifejackets on diving board.
- 32. No catching off diving board.
- 33.No reverse dives.
- 34.No"gainers".
- 35. No handstand dives.
- 36. No chain dives.
- 37.Look to make sure water is clear of swimmers before jumping.
- 38. If assistance is needed to dive; diver will be asked to stay off diving boards.
- 39. Breaking these rules may result in ejection from the pool.
