Approval of Minutes – Motion by Reilly second by Morrissey to approve the minutes of the August 20, 2025 Council Meetings. All aye, motion carried.

Committee Reports – Jackson gave an update regarding a Comprehensive Plan review meeting that took place with positive feedback. The Council will receive a report from SWWRPC at a future meeting.

Police Chief Report – Chief Jerry emailed the report; there were no questions.

Industrial Park Agriculture Lease – The Council discussed the process for leasing several acres of agriculture land located in the industrial park. They considered using a bid process, as well as including an opt out clause in case the property is able to be developed before the terms of the lease expire. They reviewed comparable lease agreements used by other municipalities. Wedige asked Tom Lethlean for his opinion, which is for the City Council to set the terms of the lease agreement and then advertise for bids. Wedige questioned whether a bid process is required. Morrissey instructed the clerk to ask for a legal opinion on whether or not the lease should be advertised for bids. No action taken.

Introduction of Ordinance No. 326 Amending Section 46-309 of the City of Shullsburg Municipal Code –The Council reviewed an ordinance amendment that will be up for discussion at a public hearing and upcoming council meeting on October 15th related to reducing the minimum parcel size required for a Planned Unit Development.
